Approximately 40 persons attended our last meeting and observed a very interesting and important demonstration of Cardio Pulmonary Resusicitation (CPR) methods by a representative of the Arlington Red Cross. Additionally, a proposal then before the County Board to convert the old Duke's Photographics premises on Columbia Pike into a combined dancing and restaurant facility, was debated and explained by the owner, Mr. Biaz (the Board subsequently approved the use of the premises as a restaurant exclusively).

## HIGH BARCROFT PARTICIPATION IN NOVEMBER 7TH ELECTIONS!

The unusually mild weather and several exciting races apparently contributed to an exceptional turnout on the part of Barcroft precinct voters. Of Barcroft's 1869 registered voters, 62.9% actually cast ballots compared to 58.6% in the 1977 elections. Overall, 58.3% of Arlington's eligibles went to the polls this year, up from 54.7% last year.
