## **FEBRUARY MEETING: Hi Cue Billiards**

January's meeting of the Barcroft School and Civic League included a report on the letter sent to the Arlington County Board about Hi Cue Billiards. This generated a discussion of concerns and questions about the establishment. A *Washington Post* reporter who attended the meeting quoted some Barcrofters in an article that appeared on January 14. One quote was, "20 years ago this was a lily-white community. There's been a change, and people are afraid. A good way to deal with it is for us to play pool there." The reporter also wrote that when he interviewed patrons at Hi Cue, their impressions were that Barcroft was primarily a community of elderly persons whose objections to Hi Cue were racially motivated. The article also reported the November 17 FBI raid of Hi Cue and a police affidavit stating that the owner threatened a delinquent gambler with death if he failed to pay up.

A motion was passed to restart the Crime Resistance Committee to work with the BSCL Board to develop an appropriate meeting timetable and format. Several Barcrofters expressed interest in joining the Committee, and

discussions with the Board led to the decision to discuss neighborhood crime at the next meeting.

The February BSCL meeting will therefore focus on crime in the neighborhood. Jim Hunter, chairman of the Arlington County Board, has agreed to attend. We have also asked Corporal Sheridan of the Arlington County Police to come to discuss crime in the 900 block of S. George Mason by specific address and to present the facts surrounding the stabbing at Hi Cue that occurred soon after the recent homicide. The police report in the last issue of the *Barcroft News* stated that the stabbing was related to the homicide.

The meeting will be held as usual in the Barcroft Community House at 800 S. Buchanan on February 4 at 7:30 PM. If you are interested in joining the Crime Committee, please call Larry Goldschmidt at 521-3746, or speak with him after the February meeting. In a future meeting we may invite the manager of Hi Cue Billiards and the various other businesses at the shopping center located at intersection of S. George Mason and Columbia Pike to explore ways to make their shopping center a safer and more inviting place for Barcrofters to shop, do laundry, have their hair done, or ... play pool.

# BSCL Tours New Library

The January meeting of the BSCL was held at the newly remodeled Arlington Central Library on N. Quincy St.—a departure from our usual custom of monthly meetings at the Community House. The purpose of this one-time change in location was to permit a very special event: a tour of the library led by Head Librarian Jayne McQuade, a Barcroft resident.

Jayne informed us that we were the first neighborhood association to visit the new library as a group. We met in the new auditorium, which can seat up to 175 and is available for the library and other groups to hold occasional meetings and special programs. After the business portion of the meeting, Jayne led our group of 20 Barcrofters on a tour of the new facility.

Although we talk of the new and newly reopened Central Library, most of us know that the old building was incorporated into the new construction and that many library services continued throughout the construction. Even now a few final touches and improvements remain to be completed. But the library is in full operation, with a bright, spacious, brand-new appearance.

The Central Library now includes a special enclosed room for children's programming (the Rabbit Hole). There is an expanded audiovisual section, eventually to include equipment for previewing disks, tapes, and videos before taking them home. The Virginia Room, still temporarily located at the Columbia Pike branch, will occupy its own space with paneling and other improvements provided by private donations. The main stacks are all on the second floor, along with periodicals and the reference collection. There is an elevator between floors and plenty of chairs and tables. Outdoor park-

ing off 10th St. N. has been expanded to 113 spaces, and the library now boasts a well-lighted underground garage entered from N. Quincy St. with spaces for an additional 175 cars.

Arlington's library system is organized so that the Central Library serves the entire county, though there are six small branches scattered around for convenience. Located between Ballston and Virginia Square, Central is not that far from Barcroft and "our" librarian invites us all to become frequent and satisfied patrons of the "new" Central Library.

## **BSCL's Letter to the Board**

November 18, 1992

We, the undersigned officers of the Barcroft School and Civic League, hereby petition you to revoke the business license of Hi Cue Billiards, at 940A South George Mason Drive. Hi Cue Billiards is located in the Barcroft neighborhood.

Although the timing of this petition is driven by the most recent murder at Hi Cue Billiards, our concerns extend back in time over the course of approximately two years. When the first murder occurred at Hi Cue Billiards, which was followed by an attempted murder in the parking lot, we began a strenuous effort to attempt to minimize further illegal activities. Clearly, we failed.

Our efforts began with a series of conversations with the owners of the shopping center. We believe we were misled by the owners. After initial conversations, the owners stated that they would install observation cameras and a guard at Hi Cue Billiards. When neither of these actions occurred, we again contacted the owners, who expressed surprise that their alleged direction had not been carried out, and we were told that cameras and a guard would be placed at the location. This never happened, to our observation.

We also had a series of discussions with Lieutenant Haas of the Arlington County Police Department, culminating in his being the featured speaker at one of our monthly open meetings. One of the primary discussion areas at the meeting was our concern over Hi Cue Billiards, and we were assured by Lieutenant Haas that law enforcement on the premises would be stringent.

Lieutenant Haas's dedication to strenuous law enforcement at the property has been evidenced by a steady stream of monthly crime reports which cite a continuing pattern of arrests

at the shopping center for theft, public drunkenness, assault, and urination in public.

Unfortunately, last weekend's second murder at Hi Cue Billiards happened despite these efforts. Subsequent newspaper articles citing the arrest of the owners of Hi Cue Billiards for running a gambling operation on the premises and other arrests resulting from the recent late-night raid have apparently revealed substantial additional criminal activity.

For these reasons, we request that Arlington County revoke Hi Cue Billiards' business license due to a continuing pattern of illegal activity.

## **County Board's Response**

December 11, 1992

I am responding on behalf of the County Board to the letter signed by you and the other officers of the Barcroft School and Civic League, expressing your concern and opposition to the operation of Hi Cue Billiards on South Glebe Road [sic].

Since the operation of Hi Cue Billiards is permitted by-right in a "C-2" (General Commercial) District, the business did not require County Board approval. The owners have obtained the proper licenses and followed the correct procedures to operate their business.

The Commissioner of the Revenue has the authority to issue business licenses, provided taxes are current, but no regulatory authority to revoke them.

Other than the gambling activity which is currently pending court action, there have been no criminal charges made against the owner of the business. In response to your concerns and those of other local residents, the Police Department will again increase its patrols and surveil-

lance of the area through a directed patrol program.

Thank you for bringing this matter to the attention of the County Board. I appreciate your interest in combatting crime, and thank you for your laudatory remarks about the efforts of Lieutenant John Haas of the Police Department.



Congratulations to Kay and Don Loutzenheiser of S. 8th St., who celebrated their 60th wedding anniversary on December 27, 1992. Barcroft residents for 52 years, the Loutzenheisers will be moving to a retirement community in Lake Ridge this spring. They have seven grandchildren.

Kay and Don are both graduates of the University of Nebraska. Don worked for the Federal Highways and was transferred to the federal office here in Washington. The Loutzenheisers were among the first renters at Buckingham Apartments before finding their new home here in Barcroft.

Actually, their "new" home was not very new when they bought it. The house had just been updated to have indoor plumbing. The old, former outhouse still stood and, when cleaned up, served as a playhouse for the Loutzenheiser's three children. Kay says they still have the old well cover and use it to store wood.

At that time Barcroft had a country flavor. The children living on the block had lots of fun, often in the Loutzenheisers lot next door to their house, known as the "playground." A beautiful old oak tree, just right for having a picnic underneath, fell during a twister that hit Barcroft around 1970. Mrs. Loutzenheiser reports that the tree had 119 rings.

The Loutzenheisers have watched the neighborhood fill in with new homes. Kay remembers when the Barcroft Apartments were built and says they were quite nice then. Despite all of the changes over the years, Kay says that one thing has always stayed the same—the neighbors have always been friendly. People have come and gone, but she has always enjoyed the people living on her street.

When her youngest child was in high school,

Kay began teaching at Barcroft School and taught 6th grade for more than 16 years. She often sees her former students but has trouble recognizing them now that they've grown up! She retired from teaching in 1973.


