4 Mile Run Cleanup Slated for March 8

A Spring cleaning day for Four Mile Run stream has been set for Saturday, March 8. This urban waterway, which borders Barcroft, needs our help at least once a year. Trash is left behind by park users and also washes into the stream from rain runoff from county streets.

Several groups, including the Arlington County parks department and Arlingtonians for a Clean Environment, will be gathering at 9 a.m. on March 8 to begin the clean-up. There will be seven sites, ranging from Wilson Boulevard down to Barcroft Park. The sites closest to Barcroft will be in Glencarlyn Park and at Columbia Pike where it crosses the stream.

The cleanup will take place rain or shine. Participants should wear shoes that can get wet, work gloves and appropriate clothing. You may want to bring something to eat.

Sparrow Swamp Plans Topic of BSCL Meeting

Have you been wondering what are the latest developments with Sparrow Swamp? The boggy area and former beaver habitat, off the W&OD Bike Trail, was drained last year to prevent damage to the trail.

If you're interested in learning more about the swamp's past, present and future, attend the March 6 meeting of the Barcroft School and Civic League. The program will feature updates on a plan to re-establish the swamp, as well as information about the proposed expansion of the bike trail.

In recent months, neighbors have seen surveyors taking measurements near the drained swamp -- which in February was home to five pairs of mallard ducks -- in preparation for the plans to re-establish the marsh.

The meeting will take place at 7:30 p.m. in the Barcroft Community House, 800 S. Buchanan. All are welcome to attend.

It has representatives from the Neighborhood Conservation Advisory Committee, the Transportation Commission and the Civic Federation. Some were new and different: for example, in Fairfax City they have installed special warning signs and now have a \$200 fine for speeding on a neighborhood street. Arlington County has already changed its requirements for all-way stops, and has installed a number of them in various locations.

Project to Upgrade Streetlights in Barcroft

The February BSCL meeting heard Sherrell Crow of the Public Works staff on upgrading streetlights. He explained how the new style lights on Buchanan are much more efficient and direct more light on the ground. They are also better at preventing light from shining into bedroom windows, and can be adjusted for individual homes. The contact in Public Works for starting the process on your street is Keith Harkins at 358-3575. Some upgrades can be done very quickly from available funding.

Scott Brinitzer has volunteered to coordinate a neighborhood-wide effort to upgrade all Barcroft lights to meet the new standard, providing adequate lighting everywhere and the improved esthetics of a uniform neighborhood light. This is important if adding light to one street simply pushes crime to the next one.

To prioritize neighborhood requests for streetlight installation, Sherrell developed and left with us a suggested

formula and a Lotus spreadsheet to calculate relative scores. Give Scott a call at if you are interested in working on the project. This will require funding though the Neighborhood Conservation program.

Barcroft Renovation Bids Expected in April



Foxes: from The Arlington Environment newsletter (adapted by Kathy Kerr)

One of the most exciting animals in Arlington is the fox, which might be seen trotting through the woods on a sunny winter day, or paying a surprise visit to your back yard. The red fox is a resident of meadow and edge habitat, although the grey fox, a woodland species, may also be around. Foxes are active in late winter, mating in January and February and building dens shortly thereafter. They are most active at dawn and dusk.

Erika Very, an Alexandria wildlife rehabilitator, says that habitat destruction is a major reason people see foxes in the daytime. "With all the construction going on, foxes are frequently being evicted from their dens." Also, when the kits are young, the male may have to forage all day to feed them. The kits look like kittens, she says, for which they are often mistaken.

The fox's reputation for intelligence is well earned. While not as adapted to city

life as raccoons or opossum, they have learned to take advantage of the human world. A fox typically develops a circuit which includes dog food bowls and trash cans, although their diet primarily consists of rodents [rats and mice!], insects, and berries. Their range is usually one to two square miles, but they often travel farther, especially in winter. Contrary to one popular notion, they do not typically kill cats. For that matter, they are no bigger than an average cat.

Denise Chauvette of Gulf Branch Nature Center advises that some times the fox misjudges human habits. They may build a den under a back porch which is not used during the winter, only to be surprised when the humans come out in the springtime. Chauvette has received

calls from distressed residents about foxes showing up in back yards. "People assume that something must be wrong with the animal," she says, "but in fact the fox probably thinks it has found a safe place to loaf." A few years back, a red fox was a regular visitor to Gulf Branch and would stretch out on the roof of the Nature Center on sunny days.

Foxes bring out a variety of reactions in people. Some see them as threatening, others see them as cute. Foxes can carry rabies, and while rabid foxes are rarely encountered, they tend to be unusually aggressive. Like all wildlife, foxes are not pets and should not be approached. However, from the right distance, their presence in our community is a special treat to be enjoyed.

Arlington Group Eyes Ways to Control In-fill

A subcommittee of the Neighborhood Conservation Advisory Committee has begun work on recommendations for controlling in-fill development. In response to inappropriate in-fill houses, some communities have "lowered height requirements (Burbank, CA), limited house square footage (Beverly Hills, CA, Gulf Stream, FL and Hillside, Chicago), and limited land coverage (Mission Hills, Kansas City)."

Ted Weihe of Yorktown neighborhood believes that the County has the power to: (1) change the current "coverage requirement" limiting the percentage of the lot that can be covered by a new house; (2) reduce the 35-foot building height limit; (3) restrict pipestem development; (4) set new county policy guidelines for the Board of Zoning Appeals; and (5) increase penalties for developers who break the rules and reward those who are sensitive to neighborhoods.
