And once renovations are complete, it will become an even better place for community events and for use by residents for private parties and other occasions.

Demeter, and more at the meeting expressed willingness as well. There is immediate need for landscaping help, probably best approached by emailing Scott Brintzer at [sbrintzer@aol.com](mailto:sbrintzer@aol.com). Scott is the Barcroft landscape designer who has been helping Vanguard spruce up the property. Volunteers can also call Marlyn McKants, the Program Director for Demeter, at 533-1365 ext. 11 (voicemail) or Kathy Dooley, 533-1365 ext. 16. Volunteering is complicated by the fact that the location of the house is confidential to prevent complications for the clients who live there, and there are Federal confidentiality requirements that the residents must waive for a volunteer to assist. But it can be done!

In all, it was clear from the November meeting that the Barcrofters present, whatever their initial position regarding the program, wanted to put the past difficulties behind them and move on to help this program fit as well as possible into the neighborhood. Vanguard's evident good faith in adhering to the conditions of the use permit has been the key to moving forward. We have closed one chapter in this saga, and as we open the next one it looks like it will be a much better read.

## **Demeter: This Just In**

County staff say they'll probably oppose the idea of reviewing Demeter's zoning use permit again in six months, as the neighborhood requested. Instead, guidelines indicate to staff that the second review need not occur for another year. The board will weigh their opinion against

the neighborhood's and make a decision. The BSCL urges people who want to support the neighborhood's position to attend the county board's Dec. 11 meeting, which begins at 9 a.m. at the 2100 Clarendon Blvd., 3rd floor. # Pay BSCL Dues – Why?

There are approximately 800 homes in Barcroft, not counting the apartments. The

membership form goes out in September each year. As of early November, 223 (28%) of households were paid members. Last year the final count was 290 (36%), and the year before was 281 (35%); 1996 was significantly greater with 366 (46%).

# **New Demeter House Era Begins: BSCL Makes Demeter Residents Honorary Members**

At its November meeting the Barcroft School and Civic League discussed its relationship with Demeter House, a large group house in the neighborhood. The occasion was our preparation for a County Board hearing on renewal of the use permit granted to Vanguard Services for the program.

We have documented on other pages the long battle over the initial decision to place this large program in a residential house on a quiet Barcroft street. When the County Board decided to grant the use permit, several families around the site chose to move out of the neighborhood. Given their bitterness, the decision to leave was not unreasonable, although it left behind a bad taste for the harshness of the adjustment process, and dampened any enthusiasm for early acceptance of the program.

In the interim three years, Vanguard used the house for some time as a dormitory for men from the Phoenix program who attended program activities elsewhere during the day. There was no neighborhood friction from that usage. Then in the spring of 1999 the program was finally moved to the house from its former inadequate location.

Our neighborhood liaison committee, headed by Daphne Miller, has maintained close contact with Vanguard during the

interim period, and now is keeping a watchful eye on the operation of the program. There are 29 special requirements in the Vanguard use permit, ranging from a limit of 18 clients to how the trash is to be handled. The close observation of those special requirements is the key to having the program fit in our neighborhood.

At this meeting of the BSCL the program received a good report card. The only recorded complaints have been about one speeding van driver, spillage of trash from over-laden trash cans on pickup day and weeds in the yard. (Loud music that had sparked another complaint on one occasion turned out to be from another house.) The general tone of the Barcrofters present was wary due to only six months experience, but approving of the way the program is being run to date.

The BSCL adopted unanimously a motion to report our good experience to the County Board but ask for another review of the use permit in six months as we continue to monitor the program closely.

The BSCL also adopted a motion to grant honorary membership to the 18 Demeter House residents. We expressed a hope that we can develop closer communication with the residents and be part of their rehab program. We invited them to come to our Christmas Program in December (and all other programs), and the Vanguard staff intends to organize a caroling stroll through the neighborhood with Demeter residents and Barcrofters as Christmas approaches. A number of Barcrofters have already volunteered to help out at

# Barcroft Votes

Barcroft turned out more than 40% of our votes for the last election in this century, with 758 voters and 16 absentee ballots. That was much better than the 34% county-wide, and beat all but four other precincts. Your vote ensures that the neighborhood will be heard!

The heaviest hour was 7 to 8 a.m. (105 voters) and the lightest turnout was during the rain from noon to 4 (about 30 per hour). More than half of us (404) had voted by noon.

For County Board, Paul Ferguson (D) won 432 votes, followed by Mike Lane (R) with 386, Charles Monroe (D) with 379 and Frances Finta (R) with 212. Ferguson and Monroe won Countywide. For School Board, David Foster won Barcroft with 374 votes to Sharon Davis's 350, reflecting the countywide result. For State Senate, Mary Margaret Whipple won 496 of our votes, with Scott Tate receiving 223. Others were uncontested, including Barcrofter Karen Darner with 586 votes as our State Assemblyman, and Barcrofter Dick Trodden with 607 votes as Commonwealth's Attorney.

Our election officials this year included long-term Barcrofter Elizabeth Call, and newly arrived Barcrofter Michael Collier as Precinct Chief. Mike did a great job of keeping the proceedings well organized, and will be an asset to the neighborhood. You can be an election official next year, and it pays \$85 for the long day. Call the Registrar at 228-3456 for details.

# Barcroft School Needs New Playground

Barcroft Elementary School needs a new playground! With current enrollment approaching 550 students, a hundred or more children are outside during any given recess -- more than the existing equipment was designed to serve safely.

For several years, Principal Miriam Hughey-Guy has asked the school system to expand or replace the current play equipment, but her request has been denied. Now she and the Barcroft PTA are trying to move ahead with this project as best they can.

Ms. Hughey-Guy is looking for parents -- or anyone in the community who is interested -- to serve on a committee that will look over various designs and vendor proposals and make recommendations for funding this project. There are community grants that Barcroft might be able to obtain; it's also possible the school system would look more favorably on Ms. Hughey-Guy's next funding request if neighborhood support is strong.

Barcroft parent Lander Allin, who helped Alcova Park gain funding for the playground renovation that will be carried out next year, is on the Barcroft committee, but more volunteers are needed.
