# **New Warning System**

Arlington is installing a new warning system for emergency messages.

It uses a horn followed by a clear voice message. The speakers are on utility poles, mostly in Rosslyn, Clarendon and Pentagon City. Testing can be silent or deliver a test message. Audible tests will be announced before they begin.

The system can reach people who do not have mobile devices, are visiting, or are outside and away from television, radio, and telephones. It can be used in one neighborhood, helping police look for a lost child, for example. This pilot program is federally funded.

The system supplements Arlington Alert text messages to your mobile device and email. Arlington also uses commercial broadcast media, its web site and 1700AM Radio Arlington. In addition, Arlington uses Reverse 911 phone calls for highly localized needs

#### Free Native VA Trees

As part of its Neighborhood Day activities, Arlington County is sponsoring the annual tree giveaway to county residents May 12, 2007.

The two species available this year are native trees highly recommended for this area. One choice is The Fringe tree (*Chionanthus virginicus*) is a small flowering tree with year-round interest. The other choice is The Black gum (*Nyssa sylvatica*) is a medium-to-large shade tree with spectacular red fall color. The trees are in one gallon containers and their height should range between three and four feet. This is a good size for transplanting and future growth success, and is small enough to handle with ease.

# Residents need to place their order for trees by April 6th.

## **Neighbors Share Their Story**

Two and a half years ago while browsing at the Arlington County Fair, one of the exhibitors looked me in the eye and asked directly, 'Are you interested in becoming a foster parent?'

My answer was indecisive, 'Well, yes and no'. I'm willing to help children in need but what about the long-term commitment? She took my name and number and I wandered off to the next booth.

Today, I am thankful for this encounter. It marked the beginning of my husband's and my participation in Volunteer Emergency Families for Children (VEFC). VEFC is a statewide non-profit organization that provides emergency and respite foster care to children in need.

Most people think of foster care as a longterm commitment. Children come into your home for months or years. VEFC, however, addresses short-term needs of up to 3 weeks.

In the past year and a half, we have hosted about ten children, ranging in age from 7 months old to 15 years old. They stay for a weekend, a week and even three weeks (the VEFC limit).

Not all placements are a result of recent removal from the child's home. Some involve respite, which means that the regular foster family would like a week or a weekend off. Recently we cared for 2 young siblings; while they had endless energy, they were wonderful companions. While sitting at the dinner table, they said, "I like you." We liked them, too.

Another young teenager liked riding bicycles, so we cycled down to the W&OD trail for a ride. We skipped stones into Four Mile Run trying to get across the creek without getting wet and tossed really big boulders into deep eddies to see how tall of a backsplash we could make.

We cared for another teenager for a few nights. She missed her regular Saturday morning bowling league so we offered to take her bowling. We threw gutter balls and knock down a few pins.

We heard later that the young teen asked to come back for another weekend with us.

One young man wanted to attend his church during the week he stayed with us. The warmth of the pastors and the caring environment in his youth group was overflowing. Dan even had a chance to practice Spanish while he was there.

We both have concerns about the problems that children in transition may feel. It is easy to imagine children acting out in frustration against the yanking on their heartstrings and changing environment. Knock on wood; none of the children we've opened our home to has demonstrated significant anger and/or frustration at their situation. We know that could happen someday, but we are willing to risk it, knowing that we are providing a safe and caring environment for a child for a short while.

Little did we know how rewarding this experience would be for us. We miss the kids when they move on, even though we've only had a short time to get to know them. However, the phone will ring again, offering us another chance to provide a much-needed service to a youth in our community.

Volunteer Emergency Families for Children (VEFC), whose mission is helping children and youth in-crisis, recruits, trains, and supports volunteers who provide short-term (1-21 days) shelter care and mentoring to abused, neglected, runaway, homeless, and at-risk children and youth throughout Virginia.

VEFC has an on-going recruitment system. The Northern Virginia branch is not only looking for foster families, but also others to serve in a variety of ways -- recruitment, public relations, annual picnic coordination, etc.

### **Barcroft Historic Lustron House**

Once there were eleven and now there are five---as Arlington's inventory of Lustron houses continues to dwindle. All of the Lustrons in Arlington were built in 1949 and where the "Westchester Deluxe 02" model with two bedrooms, and one bath in 1,093 square feet of living space, a really cozy fit by today's standards. But in post-WWII American these prefabricated metal porcelain enamel houses were marketed as a "new standard of living."

The house arrived in a kit that contained every panel, nut and bolt necessary and not a stick of wood. Everything was made of steel, including the roof shingles. Impervious to termites, fire and weather, the houses never needed painting. But, to quote Sam Samuels of the *New York Times*, "What time and wind cannot bring down, real estate prices

can, especially when the land the Lustron sits on is worth more than the house itself." Such is the story of the Lustron house that formerly graced a corner lot in the Virginia Heights neighborhood on South 12<sup>th</sup> Street. From the *Washington City Paper*: "'My original idea was to tear it down, but when I discovered that the thing was historic, I decided it would be better to save it,'" remarked the property owner. He donated the house to Arlington County, which is looking for someplace to put it. For now it is boxed, relegated once more to "kit" status, awaiting rebirth, once again the "house of tomorrow."
