#### IMPORTANT ELECTION DAY FACTS

In the November 1977 election, only 54.7% of the registered voters in Arlington actually casted ballots. Barcroft precinct did better then this average with a 58.6% turnout. This year, with the convenience of early voting at the Courthouse if one cannot be around on election day and an active precinct organization for most candidates, Barcroft's participation should be much higher.

ELECTION DAY (continued from front)

Residents of Barcroft precinct vote at Barcroft School, 625 S. Wakefield Street. Polls are open between 6AM and 7PM. Anyone standing in line at 7PM (no matter how long the line) will be allowed to vote.

Many persons do not know that, if they cannot be in the County on election day because of business, etc., they can vote now by going to the Registrar's Office on the first floor of the Courthouse, filling out a simple application, and immediately voting on a machine there. This procedure can be utilized until 5PM, Saturday, November 4th (call the Registrar's Office- 558-2345/6- if you need more information).

Assistance in voting before or on Election Day is available through the campaign offices of both Steve Detwiler (521-0680) and Joe Pelton (525-5994).

Candidates up for election this year are: U.S. Senate- John Warner (R) and Andy Miller (D); U.S. Congress- Frank Wolf (R) and Joseph Fisher (D); Arlington County Board- Joe Pelton (ABC-D-I), Richard Gardiner (Libertarian-I), and Steve Detwiler (R-I); and the three candidates for Arlington Commissioner of the Revenue- Geraldine Whiting (D), Clyde Boden (I), and Leo Urbanske (R-I). Additionally, two referendum questionswhether to authorize pari-mutuel betting in Virginia and whether to give the General Assembly the power to exempt certain classes of renovated property from taxes.

A copy of the OFFICIAL ballot will be available at our next meeting for your review.
