BSCL Moves to Oppose Demeter House Plans

After members voted to oppose a special use permit for a proposed group home, the BSCL is organizing residents to make their voices heard at an Oct. 5 County Board meeting on the issue.

"We are actively fighting the plan as proposed," said league President Jim Kerr. Rocco Saracina, a Sixth Street resident, and a group of other residents, will be organizing block captains to mobilize Barcrofters to show up at the Saturday county meeting.

Vanguard Services, which operates two adjoining group homes for recovering addicted mothers and their children, has an option to buy a six-bedroom house in Barcroft. The agency wants a special use permit to combine the two current group homes, in the Douglas Park neighborhood, into a single home, Demeter House, at 4317 S. Sixth. It would hold 22 residents and a number of staff members.

Kerr emphasized that although objections to the proposal range widely,

the major stumbling block is the size of the group home.

If Vanguard agreed to a smaller number of residents, many Barcrofters would accept the project, Kerr said. But Vanguard President Debbie Volz said at a BSCL meeting on Aug. 27 that the agency would not be willing to accept such a condition.

meeting was scheduled to review the special use permit request. But the county Board of Commissioners must make a final ruling on the matter.

Barcroft asked for and got the support of the county's Neighborhood Conservation Advisory Committee in opposing the permit. The NCAC voted 12-2 in mid-September to urge the County Board not to approve the request.

The BSCL's actions came in the wake of an Aug. 27 meeting, which was attended by more than 230 people. At the meeting, Vanguard officials spoke at length about the proposal and their operation. Saracina and other residents voiced their objections and some Barcroft residents spoke in favor of Demeter House.

A vote to oppose the group home proposal as it currently stands passed overwhelmingly. Fewer than a dozen persons voted in favor.
